Between regattas he can be found at the New York City real estate office of Charles F. Noyes Company, Inc., of which he is a Director and Executive Vice-President.




VICE-PRESIDENT IN CHARGE OF INTERNATIONAL AFFAIRS-Jay Limbaugh

Bill "Puka" was born in Honolulu and has sailed in Kaneohe Bay since 1932, with the exception of three years at Georgia Tech acquiring a B.S. degree in mechanical engineering, and three years in U.S.N.R. as electronic maintenance officer.

He took a wife and a Lightning named "Genie", which he built himself, to represent Hawaii at the 1953 Internationals at the Buffalo Canoe Club, where he was joined by Cy Gillette and Phil Fisk for crew.
