1. RULES: The regatta shall be governed by the current Racing Rules of Sailing. Appendix V will apply.

- 2. ORGANIZING AUTHORITY: Lightning fleet #187 and the Sheboygan Yacht Club, Sheboygan, Wisconsin shall be the organizing authority.

0930 - Warning signal for the first race of the day No warning signal will be made after 1400 on August 26. Closing ceremonies and awards will follow the last race.

- 5. SAILING INSTRUCTIONS: SI's will be available at the time of registration and also posted on the official notice board on the SYC dock shack.
- RACING AREA: The racing area will be on Lake Michigan in the vicinity of the Sheboygan lighthouse with specific areas to be determined by the Race Committee.
- 7. MEASUREMENT: All yachts are expected to comply with the measurement requirements as defined by ILCA class rules. Valid certification may be requested by the organizing authority.

8. VHF RADIOS: Use of VHF radios will be permitted for communication from the Race

Committee to competitors on a pre-determined channel specified in the SI's. The Race Committee will attempt to make OCS announcements as well as other courtesy

broadcasts. Each race team is responsible for having its own VHF radio and for deciding whether or not to use it for monitoring Race Committee announcements.

9. SAFETY: All boats are expected to comply with the safety equipment required by the ILCA Class Rules.

10. DISCLAIMER: The Sheboygan Yacht Club and Sail Sheboygan, its members, employees, and/or agents will not be responsible for any loss, damage, or injury that may occur to persons or property, whether ashore or at sea as a consequence of the participation of any competing yacht in any way.

11. PRIZES: Awards will be given to the top five finishers.
